- a. If music is reproduced in a booklet of words only, the copyright notices should identify the compositions to which they pertain.
- b. If transparencies or slides are used, the copyright marking must appear on the projected image. [www.goodforthesoulmusic.com](http://www.goodforthesoulmusic.com) must appear on the slide frame or transparency and any printed material provided for use at the liturgy (such as a program or Sunday bulletin).
