A. Stipend

- iii. Please remit the balance of \$500.00 (50%) to Good For The Soul Music one week before the concert.
- iv. Deposit is non-refundable.

B. Expenses:

i. Sponsor agrees to pay for the following:

Good For The Soul Music will make arrangements with
airline and then send invoice to Sponsor.
3. Meals for ___ person(s) for the length of visit.

C. Good For The Soul Music reserves the right to sell merchandise such as CD's, DVD's, and various other related products at the engagement. No commission shall be paid to the sponsor on such sales.

D. Sponsor agrees to provide two 8-foot rectangular (or similar) tables for Good For The Soul Music to set up a sales table. Sponsor also agrees to provide 2 responsible volunteers to handle sales before and after the concert.

IV. SOUND, LIGHTS, AND MUSICAL EQUIPMENT

A. Sponsor agrees to have appropriate Sound system and Musical Equipment in place at the time of sound check, **approximately 3 hours** before the scheduled performance, including;

- i. **Grand Piano, tuned**, and properly microphoned. IF a grand piano cannot be found, please provide an 88-key, touch sensitive, weighted keyboard with connections to soundboard, sustain pedal, and piano chair.
- ii. **A good Acoustic Guitar with strap, electronic pick-up, and tuned. Good brands are Martin, Taylor, Takamine.**
- iii. Vocal Microphone on Boom Stand and Direct Box (for guitar) and floor Monitor, downstage center.
- iv. Vocal Microphone on Boom Stand and floor Monitor at grand piano
- v. Appropriate P.A. and mixing console for the venue
- vi. Appropriate Lighting for the venue
- vii. A Sound and Light engineer to assist with sound check and performance.

V. SPECIAL PROVISIONS: _____

Sponsor acknowledges and confirms that she/he has read and approved the terms and conditions set forth in this agreement. This agreement is not confirmed until executed and returned to Good For The Soul Music. If sponsor cancels the concert for any reason within 60 days of the date of the concert, sponsor agrees to pay balance of concert fee and any expenses incurred by Good For The Soul Music artists for appearance. Any cancellations must be in writing.
